Mr. Sandweg. We have a series of three contracts on the long sheet that we had, Corps of Engineers, they are Contracts Nos. EA44-009-Eng-4606, 4607, and 4608. They are, respectively, with the Joy Manufacturing Co., of Michigan City, Ind.; the Arthur Orlaff Associates, of Nunda, N.Y., and Caterpillar Tractor Co., of Peoria, Ill.

They are R. & D. contracts for studies to be made on a combat emplacement excavator, which I imagine is a fancy name for a foxhole digger. The contracts were in the amount of \$44,054, \$10,400,

and \$22,000.

The status of each contract is set forth identically and it is as follows: In each instance the contractor recommended that he be awarded a contract to develop a combat emplacement excavator in accordance with a general design which he prepared. General, these appear to be three R. & D. contracts for the same item, and we wondered why this couldn't have been placed on a design competition basis, with the cost to be borne by the man who gets the contract, and the others to fall by the wayside if they desired to

participate in the R. & D.
