- Line 8: Strike out "(3)" and insert in lieu thereof "(2)".
Line 24: Strike out "(4)" and insert in lieu thereof "(3)".

Line 18: Strike out "(5)" and insert in lieu thereof "(4)".

Page 12

- Line 6: Strike out "(6)" and insert in lieu thereof "(5)".
Lines 9 through 18: Strike out in their entirety and insert in lieu thereof the following:
"(6) The term 'mortgage' means a first mortgage on real estate in fee simple, or on the interest of either the lessor or lessee thereof (A) under a lease for not less than ninety-nine years which is renewable, or (B) under a lease having a period of not less than fifty years to run from the date the mortgage was executed. The term".
