And on your second point, I feel that such an individual would be an essential member of any demonstration or coordinated development program. It is almost inconceivable to me that a demonstration or a program of that magnitude could be carried out without the expediting services of such an individual.

Mr. BARRETT. I would like you, if you will, to comment on the

optional versus the mandatory.

Mr. Fay. On the matter of the optional point, which is what I attempted to cover just a moment ago, but apparently not adequately enough, my own feeling is that this man would be an essential member of the team. And, therefore, I would have no objection to having it a mandatory requirement. I think probably our association would feel the same.

Mr. BARRETT. Thank you, Mr. Widhall? Mr. WIDNALL. Thank you, Mr. Chairman.

Mr. Fay, you indicate that \$2.3 billion is not enough for just 60 to 70 cities. What do you think would be enough?

Mr. FAY. That is a difficult question to answer. And last week even some of the best mayors in the country were not able to translate it in terms of what could be used in their own communities.

I think, obviously, if we are going to make 60 or 70 demonstrations we will probably have to have several times that amount. I think we

need the 60 or 70 demonstrations to cover the field.

Mr. WIDNALL. As I understand your testimony, you're recommending that the demonstrations be conducted in cities of great variance in size, so that we will get an example of what exactly you can do?

Mr. FAY. Yes, sir.

Mr. WIDNALL. What do you think would be enough for the entire country?

Mr. FAY. We have not made any projection of this point.

would be glad to try to do so and to furnish it to you.

Mr. WIDNALL. I would appreciate it.

May it be furnished for the record, Mr. Chairman?

Mr. BARRETT. Without objection it is so ordered.

(The matter requested is as follows:)

ESTIMATED COST OF 60 TO 70 DEMONSTRATION PROGRAMS

The administration has suggested that \$2.3 billion will be needed to fund demonstration programs in 60 to 70 cities over the next 6 years. Precise information, however, is not available on how this total fund would be distributed

among various sizes and types of communities.

Statements by the administration and newspaper articles indicate that there will be three city-size categories—small, medium, and large. In addition, it has been suggested that the amount of funds to be made available in each category will be approximately equal. Estimates have also appeared indicating that the number of large city demonstrations will be between 5 and 8, the number of medium-size city demonstrations between 10 and 12, and the number of small city demonstrations between 40 and 50.

Based on this information, it can be assumed that the annual share of the approximately \$400 million for each city-size category will be roughly \$130 million. If it is further assumed that five demonstrations are to be conducted in the large city size category, it can be stated that the annual supplemental contribution per demonstration in this category would be in the neighborhood of \$26 million. However, if eight demonstrations are conducted in this category the annual supplemental contribution to the program in each city would be reduced to \$16.2 million. Similar shifts in the other two categories produce similar results.
