## STATEMENT OF AL SHOCK, PRESIDENT, CHAMBER OF COMMERCE, SIOUX FALLS, S. DAK.

Mr. Shock. I thank you, Senator McGovern, Senator Burdick, and Senator Moss. I speak in behalf of the Sioux Falls Chamber of Commerce and Industrial Development Committee, and also as a member and past president of the South Dakota Reclamation & Development Water Conservancy, and also speak, Senator Burdick, as a farmer of North Dakota. My dad farmed up in North Dakota one year to make enough money to move to South Dakota, and I am also speaking on behalf of the businessmen of Sioux Falls and as president of the Terrace Park Dairy Co.

We employ many farm youth in the State of South Dakota and buy milk from approximately 400 farmers, so we have a very close touch with economic problems of the State of South Dakota and its economy.

We certainly, as business folks, endorse this project, and I might add, the Sioux Falls Chamber of Commerce in many, many past resolutions endorses this project in its entirety.
