STATEMENT OF LESTER DENNIS, MELLETTE, S. DAK

Mr. DENNIS. Honorable members of the Senate subcommittee, I am Lester Dennis of Mellette, S. Dak. I farm in the northern part of Spink County, in the proposed irrigation district. I am in favor of irrigation because it would eliminate one of the problems in farming—the shortage of moisture. This, to me, is a main reason for crop failure in that the moisture doesn't come at the right time or in the

proper quantity,
We have a State college in South Dakota that does much to promote advancements in farming, Research is carried on to develop new and better plants, better methods of fertilization applications,

and livestock types have been improved. We have a soil and water conservation service that helps the farmer

to prepare his land wisely.

We have new insecticides to kill pests and also weed control products. We have local banks, PCA, and FHA to help us finance our needs. They can provide many types of insurance. Hail insurance is one example. We also have good soil but we don't have the most important

insurance of all—moisture.
