This happens when the weather cooperates. One irrigator on our system now

pumps from a well and regularly gets 80-bushel yields.

The western half of our system contains a large number of livestock feeding operations—some of them pretty good sized. This year and in nearly every past year, some of the feed for those livestock had to be hauled in. In dry years, some feed has to be imported from a great distance.

Because 190,000 acres could be irrigated by the first stage of Oahe, the local source of alfalfa, corn-for-feed, and other feed grains could be assured for the

stock growers of Marshall and Day Counties.
