## STATEMENT OF JENS CHRISTENSEN, PRESIDENT, BEADLE COUNTY FARMERS UNION

Marcolli M. Torie Mr. Christensen. Senator McGovern and Senator Burdick, ladies and gentlemen, my name is Jens Christensen and I represent the Beadle County Farmers Union, an organization of some 470 farm

families or 45 percent of the farmers in Beadle County.

As far back as I can remember people living in this part of the country have off and on been exposed to a dream—a dream of green acres and lush fields right in the heart of drought and semiarid conditions. This dream was so fantastic that nobody but a fool or a person entirely immune to scorn or ridicule would dare to discuss this and then only among his closest friends. To make this dream come true, the plan was to channel water from the Missouri River across country to the broad, flat land of the James River area, where it would be used for irrigation.

At this same time, way back in the golden age of the twenties, another dream equally as fantastic as this first one, was going around. This was the dream of bringing electricity into every farm and ranch home in South Dakota. That dream has already been realized with the help of the Federal Government.

Today we again stand before a committee representing our Federal Government to ask their aid in making this dream for irrigation come
