Administration Commissioner Truman E. Gore.

Mr. Dye has reported that this indeed is a problem, and is proving damaging to our own efforts to locate and obtain surplus property. While Mr. Dye recognizes that it would not be economically feasible in some cases to return property which is located overseas, he feels that property located in the United States could be released by AID in many cases for local programs for the assistance of our own hospitals, schools, and civil defense agencies, and the like.

Mr. Dye reports that the problem further is compounded by the fact that other agencies, such as the Office of Economic Opportunity and local community action groups currently enjoy a higher priority status in obtaining such equip-

Mr. Dye supports your bill S1974, and would be glad to provide additional supporting information, if you should desire it.
