II. PROPOSED LEASING REGULATIONS ARE PREMATURE.

The "swap" or exchange and leasing regulations proposed by Secretary Udall would give away too much too soon to the many people or entities who will be able to take advantage of the regulations if they are adopted as Federal Government policy. I will explain why in this statement.

III. OIL SHALE VALUES

Every American, according to former Senator Paul Douglas owns today in (A) Ownership per person the vast public domain oil shale reserve in Colorado, Utah, and Wyoming at least 8,500 to 10,000 barrels of recoverable oil. See 33rd article in my oil shale series published July 6, 1967. Each American thus owns oil shale worth approximately \$25,000 if it could be extracted.

contained in 4 million acres of the richer oil shale lands. However the real rich oil shale lands are situated in roughly 200 square miles of land in Colorado, and a single 5,120 acre shale lease could embrace all the oil shale lands having a thickness of 1900 feet averaging 25-gallon-per-ton shale,

Roughly 50 trillion barrels of shale oil reserves are contained in 7 million acres of the poorer shale lands. The present value of the oil shale deposits and their associated mineral values is in the neighborhood of \$5 trillion to \$6 trillion. But it is forseeable that 8 to 10 years from now when oil shale development on a large scale is expected to occur, the oil shale lands in Colorado, Utah and Wyoming will be worth \$8 trillion to \$10 trillion if not more.

At present 70 percent of oil shale land in Colorado, Utah, and Wyoming is publicly owned as public domain, but 80 percent of the shale oil in such land is

However the American people will not own this public resource for long if publicly owned. past and present policies are allowed to continue.

IV. BONA FIDE DEVELOPMENT OF OIL SHALE ADVOCATED

Let me make one point crystal clear, I am for development of the West's oil shale resources. I want progress, but I want real honest-to-goodness development of the public lands for the public benefit.
