you call term papers, and I will have my term papers in on time for your consideration.

Senator Morse. I appreciate that very much.

Mr. Hagenstein. I have just one last statistical thing I would like to make one short reference to and ask that it be inserted also. I apologize that it is not typewritten, but it is in the handwriting of one of my colleagues, so it is legible. If it were mine, it wouldn't be.

This is a tabulation showing the sales of State of Washington timber during the first 10 months of 1967, and these are sales that were purchased by trading companies who were in the export business with the Japanese. It outlines the sales, who the purchasers were, the volume of the sale, the total appraised price and the total bid price, and the total shows that the export sales were 20.8 percent of the total volume sold, and that the overbid on them was 76 percent. I would ask that this tabulation be included as part of the record.

Senator Morse. The memorandum will be made part of the record and it will be delivered to counsel of the committee with instructions of the chairman that it be typed and made available for the official

reporter and for members of the committee.
