DEAR SENATOR MORSE: At your request the Associate General Counsel of the Select Committee on Small Business sent me the testimony on log exports of Deputy Assistant Secretary for International Affairs John R. Petty before the Subcommittee on Retail Distribution and Marketing Practices. You asked if I would submit a comment for the record on this transcript

As Mr. Petty testified, the Treasury paper on log exports had been an internal staff document. It had not come to my attention, and I share your concern about the publicity given to it and the failure to follow standard government clearance procedures. As Mr. Petty emphasized at the hearing, the staff paper was intended as a "think piece" for use in inter-agency discussions. It was indeed unfortunate that the paper entered the public domain especially since it did not have the benefit of a thorough review from all the Departments concerned. I would emphasize, as Mr. Petty did, that the paper was not prepared by forestry experts, but was intended to bring the balance of payments viewpoint into the discussions on our policy toward log exports.

I am very much aware of the economic problems resulting from the present situation with respect to log exports. It is my hope that a timely solution to this problem can be reached that will include a policy mix satisfactory to all parties in interest.
