Mr. Conable. One last question: Is there any pattern that emerges in the percentage of sales disclosing those that are domestic and those that are foreign?

Mr. Grimes. At the moment I would say, judging not only from my own business but from what it says in here, about 60 percent is inter-

national business and 40 percent is domestic.

Mr. Conable. In other words, not only is there a higher commission for the international travel but there is a higher gross?

Mr. Grimes. Yes.

The CHAIRMAN. Are there any further questions?

Mr. Grimes and Mr. LoFrisco, we appreciate both of you coming to the committee. We compliment you for the forthrightness of your responses to our questions. You have been very fine witnesses.

Mr. Grimes. Thank you very much.

Mr. LoFrisco. Thank you, Mr. Chairman.

The CHAIRMAN. Mr. Meyer.

Mr. Meyer, if you will identify yourself for the record by giving us your name and the capacity in which you appear, we will be glad to recognize you.

Mr. MEYER. Thank you, Chairman Mills.

My name is Morton L. Meyer. My company is Open Road International in St. Louis, Mo. I am president of and appear in behalf of the

Creative Tour Operators Association.
