PUBLIC ASSISTANCE CASEWORKER

This is professional public assistance casework at the beginning level but does not include the trainee. An employee in this class, after a brief orientation period, is expected to carry a full case load, establishing eligibility and extent of need, and explaining laws, regulations and eligibility requirements to clients and other interested persons. This class usually requires graduation from college, but in some States, experience in related fields may be substituted.
