SANITARIAN

This is the professional entry position in environmental sanitation work which involves the application of sanitary science in the control of communicable diseases, the promotion of health and safety, and the solution of environmental health problems. Under the supervision of an experienced sanitarian or health officer, an employee in this class assists in the enforcement of public health laws and regulations by means of investigational and educational activities. The incumbent may supervise and train sanitation aides and inspectors engaged in routine inspection and sampling work. This class usually requires no experience but requires college graduation with undergraduate or graduate courses in physical and biological sciences.
