

we are beginning to serve? Do you see any other way that we can strengthen graduate schools other than direct grants?

Dr. PFAUTZ. No. I believe in this.

I would agree with Mr. Peiffer that this is what we are going to have to have. I am just concerned that, let's say, in your deliberations that increasingly you have access to kinds of differences, conflicts, and problems and issues that are involved, that to make an impact on the graduate school you have to have a grant of considerable size because graduate education is fairly costly education and it would be quite different from title III, as Mr. Brademas observed, where you spread this out.

I would hate to see large sums of money, you know, that are not large enough to do the job. I would hope and I know it would be in your minds when you deliberate, and I am certainly 100 percent for the idea of a program to support graduate education, to support undergraduate education. And I am certainly committed to the cooperative program, but they are three quite different affairs. I think this is my major concern to communicate.
