"Whereas, the importation of foreign beef produced at a small fraction of the cost of production of domestic beef poses a threat to the survival of the commercial cattleman under the present imposed quotas due to the fact that the whole years quota may hit our market at a time when our supply of grass beef is high, and

Whereas, hearings began this week in the Ways and Means Committee of the United States House of Representatives on a bill sponsored by the American National Cattleman's Association, to correct this possibility, and further cor-

recting the present law;

Now therefore, the board of directors of the American-International Charolais Association with a national membership in excess of 6,100 at its regular Spring Board of Directors Meeting held at Hershey, Pennsylvania, June 1, 1968, unanimously recommended to the Congress of the United States the passage of this bill at this session."

Your support of this pending legislation not only is needed but is necessary for

a continued strong American beef industry.
