DEAR CONGRESSMAN MILLS: We are writing you in connection with the recent tariff hearings your Committee has held, specifically the existing tariff duties on

unwrought aluminum.

Since we rely considerably on imported aluminum from Canada for our requirements, we definitely favor Alcan's stand, i.e., to reduce or, preferably, eliminate the U.S. import duty on aluminum ingot products. This would provide us with an even greater opportunity to buy metal from whomever we choose, domestic or foreign. As we see it, there would be no advantage in waiting for the European Common Market area to decide on any tariff reduction over there; we should proceed on our own and perhaps establish regional and liberal trade agreements in our own Western Hemisphere.

We manufacture various aluminum products—decorative trim and moldings, a complete line of residential building products and employ about 600 people in

five plant locations.
