New England ports. Although they produce most of the domestic supply of packaged groundfish fillets, particularly the Massachusetts trawler fleet shrank 40 percent and its catch 30 percent between 1949 and 1961.

United States policy in the postwar years has encouraged the development of the international trade, including trade in fishery products. This country's growing market for frozen and canned fish, coupled with the high standard of living and prices, have stimulated fishing countries around the world to export their fishery products to the United States. Tuna from Japan and Peru, shrimp from Mexico, Panama, and about 40 other countries, fish meal and oil from Peru, Angola, and Canada, and groundfish and flounder blocks and fillets from Canada, Iceland, Norway, Denmark, and West Germany are but a few examples unfortunately at the expense of the New England Groundfish Industry.

The slow and steady decline in the Groundfish Industry is dramatically re-

flected in the following charts and statistics.

While the comparative analysis of imported fresh or frozen groundfish fillets reveals a small decrease between 1965 and 1962, it is most important to note that blocks and slabs, which are made up mostly of groundfish fillets, have shown a 100 percent increase during the same period. Consumer trends, during the past few years, have shown strong acceptance of fish sticks, fish balls, etc., which are produced from groundfish blocks and slabs. Therefore, the overall picture indicates that imports are on the increase yearly, evidenced by the strong upswing in cooked fish products made from imported groundfish blocks, while conversely the New England groundfish market continues to decline.

New England accounts for more than 85 percent of the groundfish landed and the groundfish fillets processed in this country. The impact on this segment of the United States fisheries has become more serious each year since the Tariff Commission reported its findings to the President way back in 1956 and recommended

an increase in the tariff rates as the following table will show:
