building for fire protection, windows were repaired and general repairs made by Glenn's in Kuttawa.

When TVA came onto the scene with the LBL project we were given 30 days to remove the church. They said it must be sold. We objected and another 30 days were allowed. At a meeting with the TVA and other agencies including the Corps of Engineers a lot of buck passing was done however, TVA sent us a letter requiring the following terms be met. The letter and terms were voted on at a meeting July 2, 1967. We were required and agreed to—

1) Form a non-profit corporation

2) Agree to a minimum of \$100,000 liability insurance

3) Sign a lease with TVA (suggested 10 Years)

4) Not to lock the church and to let it be used by other groups such as Boy Scouts

5) Keep the church in as good repair or better than the present condition

6) The building could not be replaced if destroyed.

Almost one year later we still have not received the lease or contract from TVA. Mr. Milliken of TVA has said that he sent the papers to TVA's Knoxville office and he told Jim Lane if he didn't hear from them he would go down and remind them to send them.

In September or Oct. of 1967 TVA sent men into our cemetery and drove stakes at each grave. There are about 225. They tramped around over the graves and made holes in them. They did not ask for permission and were trespassing. Jim Lane called TVA's Mr. Milliken the next day and he admitted TVA did not have permission. We told them to remove the stakes. The stakes were all removed except four and Jim Lane removed them.

Since July 15, 1967 the Woodson Chapel Properties Incorporated has stood ready to conform to all terms set by TVA and have heard nothing from TVA.

GENERAL AFFIDAVIT

STATE OF KENTUCKY, County of Lyon, ss:

Be it known, that on the day of the date hereof, before me, the undersigned, a Notary Public for the State at Large of Kentucky personally appeared James Barnett who, being duly sworn according to law, did depose and say, that for the past two years he has been living in a house belonging to his cousin and being within a few hundred feet and within sight of his father's home. This past winter his father has been critically ill and passed away about March 1 during this time he and his wife were back and forth from the two houses. They were expecting their third child which was born Feb. 13.

One day he left home and went to Ray's garage. When he returned TVA had posted a sign on the house he was living in. He had not been notified by either the former owner or TVA that the property had been purchased by TVA.

On March 22, 1968 James Barnett came by the house very late in the evening about 4:30 or 5 PM. A TVA Scout wagon was parked at this house. He stopped his car on the highway and walked up to the TVA vehicle. One TVA man was in the wagon and other was in the house. Barnett stopped to talk to the TVA man in the wagon. The TVA man told him that TVA had bought the house and that he had a mirror he had taken from the house. Barnett told him he would like to keep the mirror, that it had belonged to his Grandfather. He was informed that the contents of the house belonged now to TVA, however the TVA man gave Barnett the mirror. Barnett put the mirror in his car and the TVA men got in their vehicle as if they were leaving. About fifteen minutes later Barnett saw from his Mother's house that the men had not left and were only then backing out of the driveway.

Barnett walked back up to his house. Everything was in disarray. The drawers from the chest were on the bed. Some coin books for old coins were on the bed having been removed from the drawers. A spray steam dry iron was missing. An expensive cigarette lighter and a small bottle of butane was gone. A hack saw, hand saw and other small tools had been taken from a pantry in the kitchen. A bowling ball and bag was missing. His father had been a guard at the State Prison and
