Dear Judge Serpentelli:

As you know, we have a Motion pending before Your Honor, with a return date of May 10, 1985, requesting restraints against the Township of Old Bridge in providing water connections* planning and zoning approvals, and building permits.

A key aspect of the problem is the availability of water supply, and Olympia & York would like to have the opportunity to Supplement affidavits previously supplied to Your Honor with testimony from qualified witnesses. We would be prepared to produce Mr. James Coe, P.E., a senior engineer with Killam Associates^ who would be prepared to discuss the current shortfalls in the bid Bridge water supply system^ and we would be prepared to produce .3. ^Cttariff^t6nij^ is, President, Middlesex Water Company; -td 6Hctfssr alternate Resources of water supply.

We would appreciate Your Honor's advice as to whether or not these witnesses would be permitted to testify, and if Your Honor thinks such testimony would be helpful to the resolution of issues in this case.
