Dear Judge Serpentelli:

I was informed by your law clerk that the Urban League plaintiffs' Motion for Court-Ordered Remedy, originally noticed for August 9, was adjourned again, from September 13 to September 20, because Ms. Lerman was not available on the 13th. We have, of course, no objection to scheduling the motion for a date when Ms. Lerman is available; indeed, we agree that her presence is important. However, as I explained to Ms. Lerman and to your law clerk, we continue to oppose any delay in hearing this matter. Unfortunately, both Mr. Payne and I will be out of state on September 20 and thus I am forced to request another date. Because we understand that Ms. Lerman is not available at all during the week of the 9th, we would hope that the motion could be scheduled for the 17th or 18th or the first day of the week of the 23rd, other than the 25th, that both your Honor can schedule and Ms. Lerman is available.

Whatever date is set, we request that your Honor direct that any answering papers be served no less than 8 days before the return date, as per the Rules.
