
Re: Old Bridge Township

Dear Judge Serpentelli:

As Your Honor is aware, this office represents O&Y Old Bridge Development Corp. with respect to its proposed development in Old Bridge Township. I am enclosing a letter sent to Mr. Norman, the attorney for the Old Bridge Township Planning Board, which indicates our concerns as to the mounting delays on this project. We have not objected to reasonable opportunities for the parties to review the facts, and support the Court's request for a report from the master. However, if the Township is going to object to the continuing participation by Ms. Lerman in this case, delay in the production of its own report, and delay the scheduling of a return date of its motion to set aside the settlement, then O&Y's interests are being significantly harmed. We are, through this letter, requesting the Court to review the progress made thus far, and to assist the parties by setting firm deadlines for the production of reports and scheduling of a motion return date.

As always, we appreciate Your Honor's continuing attention to this matter.
