
Dear Judge Serpentelli:

This is to confirm my request to your Honor made in open Court on November 22, 1985 that the Township of Monroe be allowed to make a Motion to Stay all trial proceedings pending the appeal of the denial of the Transfer Motion now lodged with the Supreme Court.
