Dear Mr. Lefkowitz:

On July 9, 1976, Judge Furman entered a judgment in the above-entitled action finding that the zoning ordinance of the Township of North Brunswick (as well as that of 10 other defendant municipalities in Middlesex County) was in violation of the constitutional obligation set forth in the Mount Laurel decision. The Township of North Brunswick did not appeal that judgment and never obtained a judgment of compliance. We have now reviewed with care the Land Use Ordinance and Zoning Map of the Township of North Brunswick, with amendments through September 19, 1983, and have concluded that they clearly fail to satisfy the requirements of the judgment in this action and the decision in Mount Laurel II. It will thus be necessary for the Township to further revise its land use ordinances and to adopt affirmative measures to afford the realistic opportunity for the requisite amount of low and moderate income housing. 456 A.2d at 490.


The trial of this action on remand from the Supreme Court is set for March 19, 1984 before Judge Serpentelli in Toms River, to whom the case has been re-assigned by the Supreme Court for all purposes. Enclosed is a copy of the Judge's case management letter-order of July 25, 1983 setting forth the time schedules for discovery. Enclosed also is a copy of the Interrogatories which we served on seven townships on November 3.

At a hearing on Friday, November 18, Judge Serpentelli granted Cranbury's motion to consolidate five other challenges to the Cranbury zoning ordinance and established a modified discovery schedule for those parties. The judge will shortly be sending a further letter-order summarizing the rulings on that date to all counsel. A further case management conference is scheduled for Tuesday, January 24, 1984 at 10:30 AM in Judge Serpentelli's courtroom in the Ocean County Courthouse in Toms River.

Finally, I enclose a copy of the report filed by Carla Lerman, the Court-appointed expert, concerning the issues of region, regional need, and fair share allocation. I will forward a copy of plaintiffs' expert's report as soon as it is distributed to all other parties.

We are, of course, willing to discuss with you at any time any reasonable settlement offers that would meet the Township's obligation under Mount Laurel II without the necessity of a trial.
