Please be advised that the undersigned has recently received the first draft of the revised Zoning Ordinance of the Township of North Brunswick from our Planning Consultant.

The municipality has recently undergone a change in the Master Plan and it was necessary to draft an entirely new Zoning Ordinance. The proposed Settlement Order provides that we have a form of ordinance approved by all parties to the Court by October 25, 1984. In light of the change in the Master Plan and necessity for an entire new zoning ordinance, it now appears that we are unable to meet the deadline of October 25, 1984, due to the amount of work the municipality has before it.

I respectfully request an extension of four weeks to comply with the Court's Order.
