Thank you for sending me a copy of the Plainsboro Township Consent Order. I wonder if I could trouble you further to send me a copy of the development fee ordinance, which is designated at Appendix B to the agreement. The reason I am interested is that I represent a developer in the Town of Clinton, Hunterdon County. That case is settlement and the settlement which will be considered by Judge Skillman within the next month includes a development fee approach to provide funds for rehabilitation and conversion. I have been unable to date to find any kind of a development fee ordinance which answers all of the questions which Judge Skillman has raised about the Clinton approach. I was hoping that Plainsboro might have an answer for me.

I am sorry to trouble you, but I have been unable to get this information from Joseph Stonaker or from the Township Clerk.
