Be it resolved, by the Mayor and Council of the Borough of South Plainfield,
New Jersey, that:

WHEREAS, Judgment, dated May 22, 1984, was entered against the Borough of South Plainfield by the Honorable Eugene D. Serpentelli, Judge of the Superior Court of New Jersey, in the matter of Urban League of Greater New Brunswick, et al, vs. the Mayor and Council of the Borough of Carteret, et al, and

WHEREAS, the Mayor and Council of the Borough of South Plainfield have reviewed the Partial Transcript of Judge Serpentelli's comments of November 2, 1984 which sets forth the penalties which Judge Serpentelli will impose, if revisions to the Zoning Ordinance of the Borough of South Plainfield are not completed and

WHEREAS, it would bring chaos to the Borough of South Plainfield if the restraints imposed by Judge Serpentelli upon the Borough of South Plainfield's Planning Board, Board of Adjustment and Building Departments, are continued, and

WHEREAS, Judge Serpentelli has stated that a stay will be granted if the Borough of South Plainfield should appeal the Judgment of Compliance to be issued by the Court, after the completion of the revision process

THEREFORE BE IT RESOLVED, that the Borough Planner be directed to complete the revisions of the Zoning Ordinance to conform with Judge Serpentelli's Judgment dated May 22, 1984 and submit said revisions to the Planning Board for their Review and

THAT the revisions, when completed, be adopted by the Borough of South Plainfield, Under Protest, so as to protect all rights of appeal to the Courts of the State of New Jersey or the Federal Courts of the United States.
