We represent Lackland Brothers who have made an application for approximately 880 condominium units before the Piscataway Town-ship Planning Board. In accordance with the PRD Zoning, the proposal before the Planning Board contains some 176 affordable housing or Mt. Laurel units.

In submitting the necessary documentation to the Township and the Planning Board, we must also submit an Affordable Housing Plan which must be acceptable to your body, the Township, the Court, and the National Committee Against Discrimination in Housing. It is our intention to utilize the method of calculation approved by those bodies for the Hovnanian tract known as Society Hill at Piscataway.
