

Dear Counsel:

Between September 16, 1976, and September 28, 1976, four motions to dismiss the above appeal, filed on September 2, 1976, by the Urban League of Greater New Brunswick, were filed with this office. The Court has now directed that it wishes to hear oral argument on these motions on Tuesday, November 9, 1976, at 10:00 AM in Room 1210 of the Essex County Courts Building in Newark. The above counsel will be the sole counsel allowed to appear and present argument. The Court has also indicated that this argument will deal only with the issue of the dismissal of appeal A-33-76 and not with the issues of a permanent stay or consolidation, which are now pending before the Court in other motions.


