

ARGUMENT

Respondent, Borough of Metuchen, hereby adopts the Counterstatement of Procedural History and Argument as set forth in the Brief in Opposition to Petition for Certification, filed by the Borough of Helmetta.

Further, respondent, Borough of Metuchen, argues that any grounds for Appellants Petition for Certification against the 11 "conditionally dismissed defendants", including the Borough of Metuchen, collapsed as a result of the Court's decision in <u>Cakwood at Madison, Inc.</u>, et als v. <u>Township of Madison and State</u> of New Jersey, A-80/81, decided January 26, 1977. Appellants only claim against the 11 defendants is the demand that they take affirmative action to secure low income housing in their respective municipalities; it was this very requirement of additional affirmative relief which the Court refused to give in the Oakwood case. Because of this direct precedent, there is nothing to litigate respecting the 11 conditionally dismissed municipalities.

CONCLUSION

Based on the above, it is respectfully requested that the Amended Notice of and Petition for Certification be denied.
