

Dear Judge:


I am prompted to write by receipt of a copy of a proposed Amended Judgment which I have received from the counsel for the plaintiffs.

As you know, the Borough presented to the Court extensive documentation in support of its Motion and subsequently provided the Court with a proposed Order which was to be held for a reasonable time while the plaintiffs and their consultant verified the information supplied by the Borough.

It is the feeling of the Mayor and Council that more than a reasonable time has passed and they are extremely anxious to have this matter concluded during 1977 so that it will not be one of the lingering problems facing the community in the new year.

In view of the intervening circumstances since July, 1976, the Borough would most strongly object to the entry of this new Order, at least as it relates to the Borough unless the Order submitted by the Borough were considered contemporaneously pursuant to Paragraph 18 of the proposed Judgment.

I once again wish to emphasize that the Borough has done everything within its power to be in full compliance with the orders and directives of the Court, but there is a growing
