

Dear Judge Furman:

I am certain you understand how distressed I am personally and how distressed the members of the Governing Body here in Sayreville were when I familiarized them with the contents of the letter from the National Committee Against Discrimination in Housing, Inc., dated January 5, 1978. The Borough of Sayreville has continually acted in good faith and has extended itself beyond what I think were any reasonable expectations.

I would even say without fear of successful contradiction that we have done 100% more than any other similarly situated municipality in the entire County.

It is now very strongly felt by my clients that the plaintiffs have not dealt with us in good faith, and that they are attempting to subvert a final resolution of this matter by a "nickel and diming process".

It is the Borough of Sayreville's abiding conviction that we are in full compliance. I would ask that you consider the moving papers of the Borough of Sayreville together with the exhibits and supplemental data which has been provided. I do not feel the necessity for any further oral argument with regard to the motion and would not see any reason for it to be rescheduled. However, if the plaintiffs feel the necessity for such oral argument, I would hope that it could be rescheduled promptly.
