Please be advised that the undersigned is municipal attorney for the defendant Township of North Brunswick.

Kindly accept this letter in lieu of a formal certification and brief in opposition to Plaintiff's motion to join the Township of North Brunswick. I apologize for the lateness of this reply. As of January 1, 1984, the Township of North Brunswick has gone through a re-organization of its form of government. As a result, I was unable to formally meet with my Mayor and Council until the date of this letter.

The Township of North Brunswick is firmly opposed to being joined in the above-entitled action. The Township feels that its Zoning Ordinance is constitutional and valid; and in any event, will be prejudiced by a joinder in this lawsuit at such a late date.

I respectfully request that the Plaintiff's motion be denied. I do not request oral argument.
