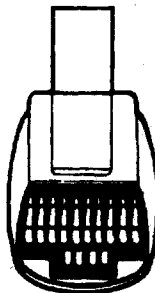

2 the case from now until one month from now.


