My dear Judge Serpentelli:


As you know, I represent the Borough of Saddle River which is involved in Mt. Laurel litigation. We have employed the services of Malcolm Kasler, a professional planner, to advise the Planning Board and Governing Body in connection with its attempts to satisfy its Mt. Laurel obligation.

I understand that Mr. Kasler has been asked to produce, in the above-entitled matter being heard by Your Honor, all of his reports, correspondence and records that he made during the year 1984 as professional consultant to the Planning Board and the Borough of Saddle River.

It is my contention that such material has a measure of confidentiality between the professional planner and the Planning Board and Governing Body of the Borough of Saddle River, and I do not believe that such material should be made available in the pending litigation and become part of the record in this proceeding. Particularly is this so if we have no idea what that material is and the circumstances under which it was presented, whether it is a public record, whether it was accepted by the Planning Board or Governing Body.

Under those circumstances, I strenuously object to this material being made available in the pending litigation.
