To All Parties on the Old Bridge Service List:

Attached hereto is the final draft of the Order, the Settlement Agreement and Appendix A thereto; These materials represent the first installment of what will be considered by the Court at the compliance hearing scheduled for January 24, 1986. I have included a marked up revision of both the Settlement Agreement and Appendix A, indicating what changes have taken place since the December 18th draft. However, no markup is included of the Order, since it has been substantially revised and now includes significant portions of the proposed Urban League Order.


Appendices B and C, which incorporate procedural and planning standards, will be supplied under separate cover, as will Appendices D and E which set forth the standards for drainage and roads. Appendices B, C, D and E are in the final stages of review by the appropriate Township officials, and are anticipated to be available by January 14, 1986.

It is my understanding that Mr. Convery will be sending out copies of all relevant Ordinances and Resolutions which have been adopted by the Township Council, or which are being adopted by the Township Council, and which form additional parts of the Township's overall compliance package.

In view of the compliance hearing scheduled for January 24, 1986, and the requirement that notice be published and materials be made available for public review, it is not possible to make any substantial modifications to these documents prior to the compliance hearing itself. However, it may be useful for us to meet and discuss these materials prior to the compliance hearing, and I would propose that we reserve Thursday afternoon, January 16, for a meeting at the Old Bridge Township Municipal building if arrangements can be made. At that time, it would be possible to identify any typographical changes which may need to be made, and, if the parties are in agreement, to execute the consent portion of the order. I will be in touch with you by telephone between now and the 16th to make such arrangements.

I look forward to meeting with you on the 16th and completing this project on the 24th,
