This matter having been brought before the court by counsel for Hills Development Co., the Public Advocate and Bedminster Township;

And it appearing that this court entered an order establishing the maximum income for low and moderate income households of various sizes in an order dated October 22, 1984, and that this order superseded prior orders of November 18, 1983 and December 21, 1983;

And the court order having failed to establish income ceilings for one person households because no such occupants were initially contemplated;

And the Bedminster Hills Housing Corporation having determined that it may be necessary to sell one bedroom units to single person households if there is a shortage of qualified two person purchasers;

And the Corporation in good faith having entered into contracts on or before December 11, 1984 with single person households, using the income standard for two person households;

And it appearing that certain single person purchasers would not have qualified as eligible low income persons if the one person ceiling had been used;

And counsel having represented that the Board has requested that a court establish the income ceiling for a one person household and clarify the status of those single person households who have signed purchase agreements;

And Good Cause having been shown;

IT IS on this        day of January, 1985 ORDERED that:

1.    The income standard for a one person low income household shall be \$11,800, and a one person moderate income household shall be \$18,550.

2.    Any unit for which a sales contract was entered into on or before December 11, 1984 to a single person household shall qualify as a low income unit so long as the purchaser's income did not exceed the low income ceiling for a two person household.

3. No additional low income units shall be sold to a one person household unless his or her income is equal to, or less than, the low income ceiling for single persons established in this order.

4. Priority in the sales of one bedroom units shall be given to two person households.
