Thank you for the copy of your letter to Ms. Dribnack of February 21. I have taken the opportunity to review the transcript and your proposed revisions and corrections.

At page 88, line 7, the transcript should read "that is, planned unit development or planned residential development," and at page 90 line 17, the word planning is correct but it should not be capitalized. I cannot find the word planned on page 101 line 9 in my copy of the transcript.
