My dear Judge Leahy:

We enclose an original and two copies of Order for Remedy, redrafted in accordance with the Court's Rulings on March 3, 1980.

If the Order is appropriate, we would appreciate your executing it and returning one conformed copy to us in the enclosed self-addressed stamped envelope. We will then serve copies on all counsel.

The changes from our original Order are as follows:

Paragraph A, line 4: "Corridor" has been changed to "Township", and the words in parentheses have been eliminated.

Paragraph C: the paragraph designations have been renumbered from G and F to H and G.

Paragraph C(3): now reads "which shall include where appropriate", referring to provisions for the planned development over-lay zone.


New paragraph D, which the Court dictated, has been inserted. All subsequent paragraphs have been re-numbered.

New paragraph E: the words "to the maximum extent possible, all" have been eliminated.

New paragraph F: the date of the Court's order, February 22, 1980, has been inserted.

New paragraph H: language has been inserted at line 7 of the description to make the Corridor co-extensive with the northern boundary of the Township near Route 206. I have used the language suggested by Mr. Gordon in his February 25 letter to the Court. The reference to Exhibit D-110 has been eliminated as unnecessary.
