
We are in receipt of Ms. Hirsch's letter dated  
November 6, 1980. We do have objection to the form of the Order.

I believe that paragraph 1 is already covered in the  
previous Order appointing Mr. Raymond as the Master, and it will  
be repeated in the form of final judgment I am preparing. It is  
therefore, inappropriate to repeat it here.

The fact that Bedminster Township and the plaintiff  
Allan-Deane are sharing the cost of Mr. Raymond equally has  
already been established and need not be repeated. More impor-  
tantly, however, the fee schedule should be effective as of at  
least September 1, 1980, which is when Mr. Raymond requested  
that it be increased, and which I thought I had agreed to with  
Mr. Hill.

If Ms. Hirsch will revise her Order accordingly, we  
would, of course, have no objection.





FEE SCHEDULE

September, 1980

Our fee to clients is the total of items I and II.

I. Technical Salary Charges

Personnel	Hourly Charge <sup>(a)</sup>
President, Executive Vice President, Senior Vice President .....	\$ 85.00
Vice President .....	60.00
Senior Level Staff .....	40.00
Draftsperson .....	30.00
Secretary .....	12.00

(a) Time required for field visit travel will be charged to a maximum of 1½ hours in each direction.

II. Other Costs

a. Travel Expenses

- (1) Airline fares at lowest available fare, at cost.
- (2) Per diem expenses not involving overnight stay – \$40 per day.
- (3) Per diem expenses involving overnight stay – \$100 per day.

b. Major out-of-pocket costs such as models, printing of large quantity of reports, multi-colored printing, and outside consultants shall be billed at cost plus 5%, except if billed directly to client, in which case it shall be at cost. No such costs shall be incurred without the prior approval of the client.

(The 5% fee is to cover our financing, bookkeeping and administrative costs for these items.)
