
Re: Urban League, et al. v. Carteret, et al.

Dear Judge Serpentelli:

As set forth in our letter of September 29, 1986 and the letter of John Pidgeon, Esq. dated September 26, 1986, we consented to Mr. Pidgeon's request for an adjournment of the Civic League's motion for fees and costs on the express condition that all defendants' answering papers would be received by us no later than Tuesday, September 30, 1986.

Today we received Mr. Pidgeon's letter of October 8, 1986, in which he states: "Unless we reach some sort of agreement in the near future, I will file a brief in opposition to your Motion for attorneys' fees and costs by October 13." Since we have not heard from Mr. Pidgeon since we agreed to the adjournment, he could not possibly have expected this issue to have been resolved. Under these circumstances, we object to Plainsboro's belated opposition to our application and respectfully submit that any such opposition should be disregarded by this Court.
