History of Beach Access

Public Beaches and the Public Trust

New Jersey Courts have long recognized that every individual has a right to access and use our beaches, which are among the state's most cherished resources. This guaranteed right to access and use tidal lands, known as the "public trust doctrine," dates back to the earliest decades following the American Revolution.

Under that doctrine, municipalities serve as trustees to manage the property for the benefit of all and they may not discriminate against residents. Private groups also may not unreasonably infringe upon public access to the beaches. The public trust doctrine is a living and evolving principle within the law. In its 1972 ruling in Borough of Neptune v. Avon-by-the-Sea, the New Jersey Supreme Court explained: "The public trust doctrine, like all common law principles, should not be considered fixed or static, but should be molded and extended to meet the changing conditions and needs of the public it was created to benefit."

The Legislature gave shore communities the right to recoup the unique costs incurred by operating a beachfront in a safe, responsible, and clean manner. New Jersey Courts have long recognized that municipalities hold this
legitimate power, but have held that it must be appropriately exercised. The Public Advocate has worked to ensure
that all individuals have a meaningful, affordable right to beach access for recreational purposes. Increased population and an increasingly mobile population have created new challenges for managing the New Jersey's priceless
shoreline in a way that fairly benefits all citizens.

In its 1972 ruling, the New Jersey Supreme Court struck down a beach fee schedule which only permitted residents of Avon to purchase season passes to use the municipal beach. The result of the ordinance was that non-residents were forced to pay twice as much to use the beach for the season as residents. The court recognized that this type of discrimination based on residency was inconsistent with the public trust doctrine, and struck down the local ordinance.

Several years later, Public Advocate Stanley Van Ness brought suit against the Borough of Deal claiming the community was improperly restricting beach access. Deal had created a Casino Club open solely to Deal residents. In addition to exclusive use of the recreational facilities at the Casino Club, members had exclusive access to the dry sand beaches directly in front of the Club. Dry sand beaches are the areas of the beach located above the mean water line. The Supreme Court extended its ruling in the Avon case, which had only covered wet sand beaches. The Court held that under the public trust doctrine, dry sand beaches directly in front of the Casino must be open to all equally, regardless of residency. In a companion case to Deal, the court held that prohibiting the general public from using municipally owned toilet facilities adjacent to a public beach was also impermissible.

In a 1984 ruling, the Court again extended the public trust doctrine to cover nominally private associations owning or controlling dry sand beaches. In that case, Matthews v. Bay Head Improvement Association, a nonprofit organization had been created to benefit the community of Bay Head. The nonprofit, which had strong ties to the municipal government, controlled a stretch of dry sand beach running parallel to the wet sand beach. Seven out of the nine roads running perpendicular to the shoreline ended at dry sand beaches controlled by the Association. Membership in the Association was restricted to Bay Head residents. The Court found that while the public had a nominal right to use the land below the mean high water line, as a practical matter the public was barred because the Association began posting guards to stop non-members from crossing Association property to get to the shoreline. The Court held that in some circumstances, the public trust doctrine implied a right of the public to pass over private property in order to reach the shoreline. In addition, the Court reasoned that the nature of beach recreation involved swimming as well as periodic rest, so there was an implied right to use the privately held dry sand beaches in a manner consistent with the nature of that recreation. The Court concluded that the Association could charge a fee to recover its maintenance and personnel costs associated with its activities, but could not forbid non-residents of Bay Head from fully enjoying the beach.

In 2005, the principles established in the Bay Head case were reaffirmed and extended to include beaches that were fully privately held. In the 2005 case, the Atlantis Beach Club was the successor to a riparian right granted by the State in 1907. It also owned a stretch of dry sand beach. In 1996, the Atlantis Club began charging a substantial fee to those who wanted to access and use its private beach. At the time, the U.S. Coast Guard owned a stretch of beach to the south which was closed to the public during summer months. To the north of the Atlantis beach there was a beach that was publicly accessible but privately owned. The Court reasoned that under these circumstances, the Atlantis Beach Club could not charge a prohibitively expensive fee for access. Atlantis controlled the only beach on the ocean side of Lower Township and there was public demand to use the beach. It also had been open to the public for a substantial period prior to the creation of the private club. The Court required Atlantis to issue daily and seasonal passes and grant general access to the public. It also ruled that the fees charged were excessive and that the State must approve the fee schedule to be charged by Atlantis. The Court explicitly rejected the notion that Atlantis could charge whatever the market would bear, and instead held that fees must be associated with the costs of running beach related activities and the number of people who could safely be accommodated on the property.

New Jersey Courts have also ruled on the issue of determining whether a beach fee is reasonable. A lower court concluded that when beach revenues are used to subsidize year-round municipal expenses, it is a form of dis-

crimination and invalid under the public trust doctrine. In 1989, Public Advocate Alfred Slocum brought a lawsuit against the Borough of Belmar charging that the town's beach fees were unreasonable and discriminated against non-residents. The Court struck down Belmar's schedule of beach fees because the cost of a daily pass was unjustifiably high compared with the cost of seasonal passes, and the cost difference between weekday and weekend passes was similarly unfair. The Court held that a community may only charge beach fees to cover those costs that are directly related to the town's beachfront activities. After a detailed review of Belmar's budget, the court found that Belmar beachgoers were improperly being forced to subsidize the town's non-beach related, year-round costs, including police, parks and recreation and garbage disposal, and these expenses should be paid for with property tax revenues.

In addition to fee schedules, the Supreme Court also has invalidated a zoning ordinance which was inconsistent with the stated public policy of using the beach for recreational activity. The town of Brick had zoned a large stretch of beach front property as single family residential but it was struck down as invalid because it did not permit public access to the beach in a manner consistent with State policy.

Lifeguards: Lifeguards are on duty at the Third Avenue beach from 9 a.m. to 5 p.m. weekends from May 27 to June 24 and daily from June 24 through Labor Day, Sept. 4.

Lifeguards staff the beach at First, Fifth, Seventh and Eighth avenues from June 24 through Labor Day. Depending on weather, the Eighth Avenue (surfing) beach will remain open for swimming weekends until Sept. 24.

Disability Access: A beach wheelchair is available.

Additional info: Only sunbathing is allowed on the beach south of the Casino to Ocean Grove and from June 24 to Sept. 4 only surfing is allowed on the beach between Eighth Avenue and Deal Lake Drive.

Restrooms: The pavilion at Woodland Avenue has restrooms, concessions, summer shops and beachfront dining. Showers and restrooms are also located along the beach.

Lifequards: The beach will be open on weekends from Memorial Day to mid-June, when daily beach service will begin. Lifequards are on duty from 9 a.m. to 5 p.m.

Disability Access: The beach is wheelchairaccessible at Garfield Avenue and on the north and south ends of the beach, and beach wheelchairs are available.

Additional Info: The beach attracts families and is popular with locals seeking to avoid the day-trippers and vacationers who fill neighboring beaches. Food and beverage coolers are permitted on the beach.

A jetty at the beach's southern end protects Shark River Inlet and is a popular fishing location. Musical entertainment is common in the evenings at the Woodland Avenue pavilion.

Disability Access: Wheelchairs are available upon request. Contact a lifeguard to obtain one.

Additional info: The boardwalk offers food stands and restaurants, including outdoor cafes, small shops and public restrooms. The beach has well-posted, restricted smoking areas.

Parking: There are change machines at Brinley Avenue and Second Avenue. Parking is free on the west side of Ocean Avenue and is \$1 per hour on the east side. Parking meters must be fed through Labor Day.

Lifeguards: Lifeguards are on duty 9 a.m. to 5 p.m. weekends from Memorial Day through Labor Day with with daily service beginning June 19.

Disability Access: The beach is accessible to those who use wheelchairs at Newark and Second avenues. Beach chairs are available for people with disabilities.

Additional Info: The one-mile boardwalk has concessions, a playground, miniature golf and a bandstand gazebo. The boardwalk continues north into Ocean Grove and Asbury Park and south through Avon, Belmar and Spring Lake.

Joggers are a common sight on the boardwalk; bicycles are allowed from midnight until 10 a.m. during the beach season. Fishing is allowed on beach jetties at Lake Terrace Drive, Park Place, and Brinley and Second avenues at the discretion of lifeguards.

Surfing is allowed at the Third Avenue beach.

Three toddler parks for children ages 1 to 4 are on the beach at Cliff, La Reine and Second avenues.

Restrooms: Two sets of restrooms are available for public use and are located on the pavilion.

Parking: Free parking is available in lots and on the streets.

Lifeguards: Lifeguards are on duty from 9 a.m. to 5 p.m. weekends beginning Memorial Day weekend; starting in mid-June, lifeguards will be on duty daily through Labor Day.

Disability Access: There are wheelchair ramps onto the beach. However, no wheelchairs are available to use.

Additional info: The pavilion, which is open to the public, has showers and changing rooms, as well as a snack bar, tables and chairs, a deck and covered porch, volleyball nets and a playground with swings.

Lifeguards: Lifeguards are on duty from 10 a.m. to 5 p.m. daily, June 29 through Labor Day.

Disability Access: The beach is not accessible for individuals with disabilities.

Additional Info: Snug Harbor is the largest of the beach areas. A basketball court, tennis court, beach volleyball court and skateboard park are at or near the Snug Harbor Beach.

In town, there are restaurants and convenience stores. Boat rentals are available at the marinas and fish markets are on or near the beaches. On the weekends, there is a farm market at Huddy Park, Waterwitch and Bay avenues.


