

CHAPTER 79

AN ACT appropriating \$7,350,000 from the "Garden State Farmland Preservation Trust Fund" for farmland preservation purposes.

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

1. There is appropriated from the "Garden State Farmland Preservation Trust Fund," established pursuant to section 20 of P.L.1999, c.152 (C.13:8C-20), to the State Agriculture Development Committee the sum of \$6,500,000 for the purpose of providing planning incentive grants to the following counties and municipalities pursuant to the provisions of P.L.1999, c.180 (C.4:1C-43.1 et seq.):

There is appropriated from the "Garden State Farmland Preservation Trust Fund," established pursuant to section 20 of P.L.1999, c.152 (C.13:8C-20), to the State Agriculture Development Committee the sum of \$850,000 for the purpose of providing planning incentive grants to the following municipalities pursuant to the provisions of P.L.1999, c.180 (C.4:1C-43.1 et seq.):

3. The expenditure of the sums appropriated by this act is subject to the provisions and conditions of P.L.1999, c.152 (C.13:8C-1 et seq.), P.L.1983, c.32 (C.4:1C-11 et seq.), and P.L.1999, c.180 (C.4:1C-43.1 et seq.), as appropriate.

4. This act shall take effect July 1, 2000 or on the date of enactment, whichever is later.
