

**CHAPTER 176**

**AN ACT** appropriating \$10,000,000 from the "Garden State Farmland Preservation Trust Fund" for farmland preservation purposes.

**BE IT ENACTED** by the Senate and General Assembly of the State of New Jersey:

1. a. There is appropriated from the "Garden State Farmland Preservation Trust Fund," established pursuant to section 20 of P.L.1999, c.152 (C.13:8C-20), to the State Agriculture Development Committee the sum of \$10,000,000 for the purpose of providing grants to counties and municipalities for up to 80% of the cost of acquisition of development easements on farmland, provided that any funds received for the transfer of a development easement shall be dedicated to the future purchase of development easements, for projects approved as eligible for such funding pursuant to subsection b. of this section. The total expenditure by the State Agriculture Development Committee from the list of eligible projects in subsection b. of this section totaling \$11,350,000 shall not exceed \$10,000,000.

b. The following projects are eligible for funding with the monies appropriated pursuant to subsection a. of this section:
