

CHAPTER 25

AN ACT appropriating \$16,250,000 from the “2009 Farmland Preservation Fund” to the State Agriculture Development Committee for planning incentive grants to municipalities for farmland preservation purposes.

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

1. a. There is appropriated to the State Agriculture Development Committee the sum of \$16,250,000 from the “2009 Farmland Preservation Fund,” established pursuant to section 18 of the “Green Acres, Water Supply and Floodplain Protection, and Farmland and Historic Preservation Bond Act of 2009,” P.L.2009, c.117, for the purpose of providing planning incentive grants to municipalities pursuant to section 1 of P.L.1999, c.180 (C.4:1C-43.1) and approved as eligible for such funding pursuant to subsection b. of this section.

b. The following projects are eligible for funding with the monies appropriated pursuant to subsection a. of this section:
